District 1 Update: January 2025

OVERVIEW OF COUNTY-WIDE ISSUES

York County Capital Improvement Program (CIP)

Happy New Year! I hope you all had a great Christmas season.

New Years means it's budget season!

Citizens are invited to provide comments online regarding the York County Budget for 2026.

The Board has not yet seen the proposed budget, but we have begun a review and discussion on the Capital Improvement Program (CIP). This is the County's six-year investment plan for major capital expenditures / improvements,

The total County budget for the current year is \$264M. Some of the major elements of the budget include Public Safety at \$55M, Educational Services at \$76M, Public Works at \$12M and County Capital projects at \$13M, School Capital projects at \$14.3M.

This year's recommended CIP for the 2026 budget increased the total for County projects to \$20M and School Projects to \$20.4M with Debt Service cost increasing by \$1.5M from \$13.9M annually.

The impact of the proposed CIP with its dramatically increased Debt Service, is that the County will reach its maximum borrowing limit in 6 years as set by the State. (Annual debt service expenditures should not exceed 10% of the total General Fund budget)

This is a lot of numbers to digest, but it basically shows the proposed current Capital Improvement Program is unsustainable. To date we've

been able to maintain the current trendline by maximizing the transfer of year end surplus funds to the Capital Improvement Program.

As our surplus decreases, a result of lowering our tax rate, we've lowered the water level to the point where the rocks are reaching the surface. We need to take a hard look at both the County budget and the York County School Division budget to determine where we can be more frugal.



SUBJECT: Colonial Parkway Rehabilitation Project Closure Flyer

In an effort to inform citizens potentially impacted by the upcoming Colonial Parkway Rehabilitation Project closure between Penniman Road and Williamsburg Circle, staff worked with the County's GIS Division to identify addresses in the Hubbard Lane area.



The news update was tied to the recent changes at the intersection of Hubbard and Penniman.

Further announcements will follow as the closure takes effect.

Mooretown Road traffic signals

Based on input from citizens living near Arbordale, I asked V-DOT to evaluate changes to the traffic signals at the entrance to Home Depot, the second entrance to Sentara at the York County Registrar's Office, and the lights at Mooretown Rd & Bulifants Blvd/Honor Ln.

At each location, a flashing yellow will be added for the left-turn advanced green traffic signal. This is scheduled for January 14 / 15th with the intent of decreasing the amount of clogged traffic on Mooretown Road at those intersections.

New Businesses

The number of new businesses in York County continues to grow, with 26 new businesses licensed in November & December, however 61 closures during that period.

The latest business licenses to be approved in District 1 are as follows:

- NP Global Solutions LLC., located at 106 Whistling Swan Court
- X Specialty Optical Fibers Inc., located on Alexander Lee Parkway

I would also like to note that this week, it was nationally announced that the Kohl's, located at the Marquis Shopping Center will be closing its doors. While this is not a surprise for those who have frequented the store, it's a further disappointment.

Marquis Shopping center opened in 2008 with the intention of creating a two phase development. The prospects for a second phase disappeared almost immediately. The financial crisis of 2008 led to the bankruptcy of the original developer and the second portion of the Marquis property converted to residential use in 2013.
